CHAPTER 5: APPORTIONMENT - TOWN WARDS

§5.1 Wards

For the purpose of electing Town Councilman of the Town of Camillus the said Town has been divided into six wards from which one Town Councilman shall be elected from each of such wards.

The wards of the Town of Camillus are individually described as follows:

WARD 1

Beginning at a point, said point being the southwesterly corner of the Town of Camillus; Thence easterly and northerly along the southerly line of said Town to the intersection of Gulf Brook; Thence northerly along centerline of Gulf Brook to the centerline of West Genesee Street; thence westerly along said centerline of West Genesee Street to the intersection of the centerline with the easterly line of the Village of Camillus; thence northerly and westerly along the boundary of said Village to the intersection of said boundary with the centerline of Newport Road; thence northerly along the centerline of Newport Road to the centerline of DeVoe Road; thence northeasterly along said centerline of said DeVoe Road to the centerline of the Old Abandoned Erie Canal; thence northwesterly along said centerline of said Erie Canal to the intersection of said centerline with the northerly line of the Town of Camillus; thence westerly along said northerly line of said Town to the northwesterly corner of said Town; thence southerly along the westerly line of said Town to the place of beginning.

WARD 2

Beginning at a point, said point being the intersection of the northerly line of the Town of Camillus with the centerline of the Old Abandoned Erie Canal; thence southeasterly along the centerline of said Erie Canal to the intersection of the centerline of DeVoe Road; thence southwesterly along said centerline of DeVoe Road to the centerline of Newport Road; thence southerly along said centerline of Newport Road to the northerly line of the Village of Camillus; thence easterly, southerly, westerly, southerly and easterly along said northerly line of said Village to the intersection of said northerly line with the centerline of the Finger Lakes Railroad right of way; thence northeasterly and easterly along said right of way to the intersection of the centerline of Bennett Road; thence northeasterly along the centerline of Bennett Road to the intersection and centerline of Warners Road, thence southeasterly along said centerline to intersection and centerline of Belle Isle Road, thence northeasterly to the intersection and centerline of Hornview Way, thence northerly, easterly, and southerly around the western, northern, and eastern boundaries of the West Colony Point tract Section A as shown on map 6365, Section B as shown on map 6594, Section C as shown on map 6833, Section D as shown on map 7643 and Section E as shown on map 6679 all filed in the Onondaga County Clerk's office, to the intersection and centerline of Belle Isle Road, thence southwesterly to the intersection and centerline of Warners Road; thence southeasterly to the intersection and centerline of to the centerline of Onondaga Road, also known as New York State Route 173; thence northerly along said centerline to the centerline of the Finger Lakes Railroad right of way; thence easterly and northeasterly along said centerline to the southwest corner of TM # 015.-04-07.1, thence northerly to the northwest corner of said parcel, thence easterly along northerly border of said parcel to its northeast corner, thence easterly across the northerly border of TM # 015.-04-07.3 to its northeast corner, thence easterly across the northerly border of TM #015.-04-07-02 to intersection and centerline of the Finger Lakes Railroad right of way, thence northeasterly to the intersection of said right of way with the easterly line of the Town of Camillus; thence northerly to the northeast corner of the Town; thence westerly along the northern line of the Town to the place of beginning.

WARD 3

Beginning at a point, said point being the intersection of the centerline of Milton Avenue and Bennett Road; thence northeasterly along the centerline of Bennett Road to the intersection and centerline of Warners Road; thence southeasterly along said centerline to intersection and centerline of Belle Isle Road; thence northeasterly to the intersection and centerline of Hornview Way; thence northerly, easterly, and southerly around the western, northern, and eastern boundaries of the West Colony Point tract Section A as shown on map 6365, Section B as shown on map 6594, Section C as shown on map 6833, Section D as shown on map 7643 and Section E as shown on map 6679 all filed in the Onondaga County Clerk's office, to the intersection and centerline of Belle Isle Road; thence southwesterly to the intersection and centerline of Warners Road; thence southeasterly to the intersection and centerline of to the centerline of Onondaga Road, also known as New York State Route 173; thence northerly along said centerline to the centerline of the Finger Lakes Railroad right of way; thence easterly and northeasterly along said centerline to the southwest corner of TM # 015.-04-07.1; thence northerly to the northwest corner of said parcel; thence easterly along northerly border of said parcel to its northeast corner; thence easterly across the northerly border of TM # 015.-04-07.3 to its northeast corner; thence easterly across the northerly border of TM #015.-04-07-02 to intersection and centerline of the Finger Lakes Railroad right of way; thence northeasterly to the intersection of said right of way with the easterly line of the Town of Camillus; thence southerly along the easterly line of said Town to the intersection and centerline of West Genesee Street; thence westerly along said centerline to the intersection and centerline of Mansfield Drive; thence northerly along said centerline to the intersection and centerline of Mansfield Road; thence easterly and southeasterly along said centerline to the intersection and centerline of Yorkshire Boulevard; thence northerly on said centerline to the intersection and centerline of Gordon Parkway; thence westerly and northerly along said centerline to the centerline of Gordon Parkway opposite the elongation of the northerly property line of Lot 12 of Yorkshire Terrace, Section B, as shown on map 4355 as filed in the Onondaga County Clerk's Office; thence westerly along said northerly line 130.95 feet to the northwest corner of said Lot; thence southerly along the westerly line of said Lot 19.9 feet to the southeast corner of the Kings Gate West Apartments property; thence westerly along said property line to the centerline and intersection of Hinsdale Road; thence northerly along said centerline to the intersection and centerline of Milton Avenue; thence westerly along said centerline to the place of beginning.

WARD 4

Beginning at a point, said point being at the intersection of Bramley Drive with the centerline of West Genesee Street; thence southerly along the centerline of Bramley Drive to the centerline of Robinhood Lane; thence westerly and southerly along the centerline of Robinhood Lane to the intersection of said line with the centerline of Sherwood Drive; thence southeasterly along the centerline of Forsythe Street to the centerline of Broadmoor Drive; thence southerly along the centerline of Broadmoor Drive to the southwesterly prolongation of the southeasterly line of Lot 176 of Stanley Manor Section '5' as shown on map 3810 as filed in the Onondaga County Clerk's Office; thence northeasterly along the southeasterly line of Lot 176 of Stanley Manor Section '5' and along the southeasterly line of Lots 176 and 175 of said Section '5' to a point, said point being the easterly corner of said lot 175; thence southeasterly prolongation of the intersection of said line with the centerline of Geddes Brook; thence southwesterly along the centerline of Geddes Brook to a point 1,000 feet westerly as measured at a right angle from the easterly line of Farm Lot 50 in the Town of Camillus; thence southerly parallel with and 1,000 feet westerly as measure at a right angle from the easterly line of Farm Lot 50 to the intersection of said line with the

southerly line of the Town of Camillus; thence easterly along the southerly line of the Town of Camillus to the southeasterly corner of said Town; thence northerly along the easterly line of the Town of Camillus to the intersection and centerline of West Genesee Street; thence westerly along the centerline of West Genesee Street to the place of beginning.

WARD 5

Beginning at a point, said point being at the intersection of Bramley Drive with the centerline of West Genesee Street; thence southerly along the centerline of Bramley Drive to the centerline of Robinhood Lane; thence westerly and southerly along the centerline of Robinhood lane to the centerline of Sherwood Drive; thence southeasterly along the centerline of Sherwood Drive to the centerline of Forsythe Street; thence southerly along the centerline of Forsythe Street to the centerline of Broadmoor Drive; thence southerly along the centerline of Broadmoor Drive to the southwesterly prolongation of the southeasterly line of Lot 176 of Stanley Manor Section '5' as shown on Map Number 3810 as filed in the Onondaga County Clerk's Office; thence northeasterly along the southwesterly prolongation of the southeasterly line of Lot 176 of Stanley Manor Section '5' and along the southeasterly line of Lots 176 and 175 of said Section '5' to a point, said point being the easterly corner of said lot 175; thence southeasterly along the southeasterly prolongation of the northeasterly line of Lot 175 of Stanley Manor Section '5' to the intersection of said line with the centerline of Geddes Brook; thence southwesterly along the centerline of Geddes Brook to a point 1,000 feet westerly as measured at a right angle from the easterly line of Farm Lot 50 in the Town of Camillus; thence southerly parallel with and 1,000 feet westerly as measure at a right angle from the easterly line of Farm Lot 50 to the intersection of said line with the southerly line of the Town of Camillus; thence westerly along the southern property of the Town of Camillus thence westerly, southerly, westerly along said property line to the centerline of Gulf Brook; thence northerly along the centerline of Gulf Brook to the intersection to the centerline of West Genesee Street; thence along the centerline of West Genesee Street to the place of beginning.

WARD 6

Beginning at a point, said point being the intersection of the centerline of Milton Avenue with the centerline of Hinsdale Road; thence southerly along said centerline of said Hinsdale Road to the southwest corner of the Kings Gate West Apartments property; thence easterly along said property line to a point intersecting the westerly property line of Lot 12 of Yorkshire Terrace, Section B, as shown on map 4355 as filed in the Onondaga County Clerk's Office; thence northerly 19.9 feet to the northern property line of said Lot; thence easterly along said property to the centerline of Gordon Parkway; thence southerly and easterly along the centerline of Yorkshire Boulevard then southerly along the centerline of Yorkshire Boulevard to the centerline of Mansfield Road; thence westerly along the centerline of Richards Road; thence northerly and westerly along the centerline of Richards Road; thence southerly along the centerline of Mansfield Drive to the centerline of West Genesee Street ; thence westerly along the centerline of West Genesee Street to the intersection of said centerline to the easterly line of the Village of Camillus; thence northeasterly and northwesterly along said easterly line of said Village to the intersection of the Finger Lakes Railroad right of way to the place of beginning.

§ 5.2 Separability

If any part of provision of this local law relating to any Ward described herein shall be adjudged invalid by a court of competent jurisdiction, such judgment shall: (1) be confined in its operation to the part or provision of this local law or the ward or wards directly involved in the controversy in which such judgment shall have been rendered, (2) not affect or impair the validity of the remaining parts, provisions or wards, and (3) not affect or impair the validity of the remaining apportionment provided for in this local law. The Town Board of the Town of Camillus hereby declares that it would have enacted this local law of such remaining parts, provisions or wards, had the invalidity of such part, provision or ward been apparent at the time of such enactment.

§ 5.3 Construction

This local law shall be liberally construed to effectuate the purposes thereof and to apportion the wards of the Town of Camillus in compliance with the ruling of the United States Supreme Court.

It is intended that this local law and the wards described herein completely encompass all the area within the Town of Camillus. It is also intended that such wards apportioned on the basis of nineteen hundred ninety citizen population, contain all the citizens resident in this Town. It is further intended that the apportionment provided for in this local law result in the creation of wards containing substantially equal citizen population. It is also intended that no ward shall include any of the area included within the description of any other ward.

§ 5.4 When effective

This Chapter is as amended by Local Law #2 of 1993 directed and approved by Onondaga County Board of Elections.
